JOB PURPOSE

The Certified Medication Aide roles is to assist the licensed nurse (RN/LPN) in providing safe and ethical care for clients-that is, administering prescribed drugs and completing other delegated nursing tasks allowed. The CMA is under the direct supervision of the Director or Nursing or the Charge Nurse of the shift.

RESPONSIBILITIES

- Dispense oral inhalation and topical medications to patients under direct supervision of a licensed nurse unless otherwise allowed by state law.
- Observe patients for drug reactions and report any problems to the nurses.
- Performing tasks associated with medication administration, including patient vital signs, calculate medication dosages and stock the medication cart.
- Recording medication administration according to program procedures.
- Assist the nurse in providing care to clients, which includes observation and reporting to resident's needs.
- Recognizes and performs tasks according to the level of education and training
- Accepts responsibility and accountability for own performance according to policies and procedures.
- Performs tasks in an ethical, legal and caring manner
- Performs tasks safely and effectively to assure residents comfort and welfare
- Respect residents rights
- Protects confidential resident information unless otherwise required to promote resident safety and welfare
- Follows federal, state and program regulations to protect own health and that of others
- Complete CNA duties on an as needed basis
- Seek guidance from the nurse as needed to perform tasks safely and efficiently
- Performs other duties as assigned.

HEALTH REQUIRMENT

The incumbent must produce a current immunization record that demonstrates a negative PPD test.

SPECIAL REQUIRMENTS

The Blackfeet Care Center is a drug and alcohol free facility and it will not be tolerated and will result in immediate dismissal. The incumbent will be required to submit to a random drug test. A refusal to submit to a drug test will result in immediate dismissal.

The incumbent must demonstrate knowledge of resident rights.

Persons found guilty of abusing, neglecting or mistreating individuals in a health care setting are ineligible for employment at this facility.

CONFIDENTIALITY
